## BOOKING TERMS AND CONDITION

To secure a booking, please send a deposit of 110 € (85 € deposit + 25 € administration fee) to the campsite together with the enclosed booking form. .

You can pay by credit card or bank transfer (IBAN: FR76 3007 7049 3911 4730 0020 008, BIC: SMCTFR2A). If renting a mobile home, a second deposit of 150 € is required two months before your arrival. In the event of cancellation, 50 % of the deposit will be returned if the cancellation is made 40 days before the start of your holiday.

If the payment terms are not adhered to, the campsite retains the right to cancel booking without refund. If you require your payments to be staggered further, please telephone the campsite reception to discuss your needs.

Full payment must be made in accordance with the terms laid out above and in the booking form. This signed booking form commits the guest to a contract with the campsite and full payment must be made even if the guest later decides to leave the campsite before the end of the booking period.

### CONFIRMATION OF THE BOOKING:

We will send you a letter confirming your booking once the first payment is received.

If, however there is no availability for your required dates, we will return your deposit in full.

### ARRIVAL/DEPARTURE

Camping pitches are rented per day from midday to midday. All departures after midday will be charged for the following day.

Mobile homes are rented from Saturday 4pm until the following Saturday 12pm. The time of departure cannot be extended unless special permission has been given the management. A refundable deposit of 350 € + 50 € will be taken on arrival to ensure against loss, damage or cleaning costs.

Guests must arrive to take possession of their camping pitch or mobile home before 7pm on the date of arrival. Failure to do this will result in the campsite assuming the guest has cancelled their booking and therefore free to rent out to someone else without refund. However, if you are aware in advance that your arrival time may be later, please make arrangements with the reception so that this action may be avoided. We would greatly appreciate a telephone call to inform us before 7pm.

### OTHER:

All guests staying on the campsite, must comply with the campsite rules.

Personal belongings remain the responsibility of the guest and no responsibility will be taken by the campsite for loss or theft of belongings. Guests should take adequate insurance against such occurrences. Safety boxes may be rented out at the Reception.

On departure, mobile homes must be left as clean as you received them, with the same inventory and without damage. Failure to comply will result in part or all of the deposit of 400 € paid on arrival being retained to pay cleaning repairs and/or purchase of inventory items.
